FEES One cat will cost £14 per day

Two cats sharing a double pen(from the same household) will cost £22 per day A minimum charge of £42 per pen applies for short term stays.

When booking, first time clients will be required to pay a non-refundable deposit of £42.

The fees are charged from and including the day of arrival up to and including the day of departure.

Fees charged are inclusive of food and heating. Veterinary insurance is also included during your cat(s) period of stay subject to the general conditions

GENERAL CONDITIONS

- Your cat can only be accepted for boarding if it is in good health and you are able to produce a Certificate or Vaccination Card confirming your cats inoculations are up-to-date. No cat can be accepted for boarding unless it has been inoculated against Feline Enteritis and Cat Flu.
- Whilst every possible attention is given to each pet boarded with us, it is boarded entirely at the owner's risk, as are cats sharing accommodation. Should we feel the need to separate them in the interest of the animals own safety, a relevant charge for the extra accommodation will be levied.
- Any current or ongoing problems with a cats health or temperament must be notified to us at the time of booking. We reserve the right to refuse any cat that we consider to be of an unreliable temperament, or sick at the start of boarding.
- 4 Should it be necessary at our discretion for a vet to be called for any health condition existing prior to boarding, all fees incurred are the responsibilty of the owner. All cats should have been wormed recently. Should any cat on arrival require treatment for internal or external parasites (fleas, worms, etc) then a charge will be levied for this.
- Any insurance for cats boarded with us whilst in our care, will exclude fees, or death in connection with any condition that existed prior to boarding, or the cost of cremation.
- We reserve the right to dispose of animals not collected within 14 days of the stated departure date if there is no communication from the owners or guardian and efforts to contact the owner fail.
- 7 We do not accept un-neutered male cats over the age of 8 months.
